SCD took an active role at NPC22 in San Diego. Under the leadership of NPC Coordinator Emma Strong, the division organized a well-attended reception and awards program at the San Diego Central Library on May 2nd, with fabulous views of the urban surroundings and the setting sun and ample opportunities for networking. Over 100 attendees enjoyed catered hors d'oeuvre and refreshments, a fun and spirited presentation about the division's accomplishments in the previous year, and the presentation of the annual Excellence in Sustainability Awards. Many awards recipients were in attendance. The new Climate Champions video was also shared, and two of the event's co-hosts - the City Planning and Management Division and the New Urbanism Division - also made short presentations (the National Capital Area Chapter also sponsored the reception). As the division's largest budgetary commitment of the year as well as one of its largest organizational commitments, the NPC reception has become a special annual event. In the coming year, the EC will be looking at ways to leverage greater partnership and co-hosting commitments to off-set its cost, which has increased substantially with post-pandemic supply and labor cost increases.

SCD devoted almost \$6,000 this year to providing 14 NPC attendance grants (both in-person and virtual) to a variety of constituents, as selected by lottery: SCD members, student members, and active volunteers. The NPC grant program was intended to enable participation and reward our members and volunteers for their involvement. In the upcoming year, we will be shifting grant funds towards supporting a similar EDI-based program of attendance grants, with the intention of increasing access to the learning and networking opportunities there.

Several EC members served as session reviewers for NPC22. Robert Kerns, one of SCD's founders and EC members, led several SMART Cities presentations as well as a mobile tour in Chula Vista. Several division members

Symposium: 1/13/22 Sustainable Communities Division First Annual Symposium: "Leadership in Climate Action and Resilience." This half day symposium included three sessions and allowed attendees to earn 3.5 AICP credits. The sessions included:

Session 1: Deep Dive - Sustainable Communities Division Leadership in Climate Action &

Resilience

Matt Bucchin (Halff Associates, Inc.) provided an Introduction to the PAS Report. This included an overview of what climate change is and why it is important to planners; an overview of mitigation and adaptation policy responses that are available for planners; and an overview of climate tools developed by planners for planners.

Scott Turner (Environmental Partners) provided an overview of the Climate Change Policy Guide. This included an introduction to the APA policy guides and how they are used; comparison of the current guide with previous versions; and discussion of the relationship of the guide with the Comprehensive Plan Standards for Sustaining Places.

Karla Ebenbach (Ebenbach Consulting LLC) reviewed the new APA Sustainability/Resilience CM requirement. She provided Information on the new mandatory AICP credit in Sustainability & Resilience and introduced the S&R Series: a webinar resource available to planners to fulfill credit requirement.

Session 2: Climate Migration Keynote

Carri Hulet (CH Consulting/Climigration Network) gave the keynote address for this symposium on climate migration. As one of the founders of the Climigration Network, Carri now runs her own practice focusing on building collaborative processes for climate projects. Carri seeks to build every project she works on around principles of equity and justice, and is increasingly creating or taking on work that is directly seeking to increase climate justice.

Session 3: Intersectionality of Climate Change & Equity Panel

Carri Hulet moderated this important panel discussion and was joined by Chris Reed (STOSS), Ladd Keith (University of Arizona), and Edith Hannigan (CAL FIRE). Ten-minute presentation from each panelists followed by discussion. They discussed how our changing climate is exacerbating inequities through flooding, extreme heat, and fire.

More than **550 individuals** registered to attend this virtual seminar.

Projects:

(1) Climate Champions Group: The SCD Climate Champions program expanded by 4 members this year to 22, representing 16 states. The Climate Champions conducted 4 business meetings, three Strategic Planning sessions, and three leadership group meetings. A leadership team was established to guide activities resulting in two Climate Champion videos for use at the 2022 APA Conference and on the SCD YouTube channel. A new Climate Champion Program Vision and Mission statement was adopted and a draft strategic plan completed to guide initiatives of the Climate Champion group in 2023.

(2) PAS Report - Matt Bucchin -

The recently published APA Climate Mitigation and Adaptation Planner Advisory Service (PAS) Report provides an overview of the basics of climate science, climate mitigation, and adaptation. It introduces how planners can move forward with climate mitigation and adaptation action to help lower greenhouse gas emissions and reduce community risk and vulnerability. It concludes by providing planners with a climate planning framework, principles for taking climate action, and

available tools and resources for moving forward.

- (4) APA Inclusive Growth and Equitable Economic Development Policy Guide Karla Ebenbach Participated in the early planning and drafting of material for the guide. Will not be able to continue contributing time to the project in the next fiscal year.

The **APA Smart Cities Interest Group**, working in collaboration with the Sustainable Communities Division, has had another productive year. Our accomplishments this year are as follows:

- -Completed an update to the APA Smart Cities Whitepaper located on our SCD website
- -Assisted APA in publishing the recent APA Smart Cities PAS Report located on our website
- -Hosted a Virtual Happy Hour at the beginning of 2022 to celebrate the APA Smart Cities PAS Report
- -Held a Business/Networking meeting at the APA NPC in San Diego
- -Completed several APA NPC presentations and a mobile workshop in Chula Vista
- -Developed a new structure for leadership going forward.
- (6) Planning 2050 Julio Carillo SCD has provided support to this nascent planning collaboration effort

The Planning 2050 (PLG2050) initiative gained momentum throughout 2022. The initial concept was developed by Julio Carillo. In 2022, Julio established social media accounts, a website (https://planningcommitment.org), spoke about the effort on a March webinar, assisted with production of a video about PLG2050, and hosted a NPC22 session. In May, an advisory board was established and Julio worked to build support for the effort from other collaborating organizations (as of December 2022 six partner organizations have joined). Several meetings of the advisory board occurred, in addition to establishment of a Development Working Group that meets monthly. In late 2022, presentations about PLG2050 occurred with other countries, including Australia and Peru. In November 2022, the first commitment letter was received from the City of Las Vegas.

It is a great way for students and emerging professionals to showcase their work related to sustainability and climate change.

We hosted a Virtual Coffee Chat Meet & Greet in October to connect with our members. We had 3 members join the chat and discussed opportunities the committee has to offer, ideas to offer members, a trivia segment, and answered further questions. It was a great networking opportunity.

Lastly, we have been working on starting up a student mentorship program to connect our student members with our professional members who want to get involved.

Since then, the Division recruited a volunteer to lead these various efforts but the individual did not, in the end, have time to devote to the role. As a result, the Division is preparing to recruit for this position anew and revisit strategic planning objectives in this area as the new year goes forward and the division devotes funds to a few equity-related actions.

APA Strategic Priorities

During FY21, APA announced four strategic priorities and intended outcomes: APA's inclusive and diverse membership, elected leadership, volunteer and staff workforce lead the way to more equitable communities; The role of planners is understood, valued, and sought after by decision makers and influencers; Planners have the knowledge, insight, and skills to help communities effectively manage change; and APA's digital business focus ensures it remains relevant. SCD supported APA Strategic Priorities this year by way of its efforts - though not fully realized - to implement dedicated equity leadership on its Executive Committee - as well as through numerous educational events it fostered, as through the Sustainability & Resilience Series. Notably, the April session entitled "Climate Resilience Includes Health: Planning in Native American Communities" focused on public health and equity, which had been identified by DC as an important priority for the year.

Division Challenges

Historically, Divisions have struggled with membership, finding active volunteers, and limited funding. SCD was challenged this year by the difficulty of adequately and meaningfully addressing equity, as it had intended, in its operations and programming but is striving to make further progress in the coming year. This year we will participate in APA's Change Ambassadors Group and renew its effort to locate a volunteer to oversee improvements in our recruitment, offerings and processes.

We were also unable to fulfill some of its budgeted climate leadership or engagement projects due to insufficient volunteer capacity. We bit off more than we could chew!
